Procedures for Converting a Foreign Driver's License to a Japanese Driver's License (Information)

[Attention and Requests]

Currently, the application process for converting a foreign driver's license to a Japanese driver's license is taking longer than usual. This is due to the fact not only many people want to switch to a foreign driver's license, but also due to reasons such as:

- Cases in which the applicant is not able to pass the document review due to lack of required documents, expiration of foreign license, etc., and is required to re-apply for the review.
- ♦ Cases in which the student failed to pass the knowledge check due to insufficient study of basic Japanese traffic rules, and had to reconfirm their knowledge.
- ♦ Cases in which the applicant has not been able to pass the skill verification due to a lack of prior safe driving practice, and need to recheck the skills.

Please understand that screening and confirmation must be done strictly, and please prepare the necessary documents and interpreters, etc. for the document screening.

Even if you have passed the document screening, please study to confirm your knowledge and practice to confirm your skills before proceeding with the procedures.


The application screening and knowledge verification will take approximately 3 months, and the skills verification will take approximately 2 months.

[Application Procedures]

Holders of a valid foreign driver's license may apply for a procedure to switch to a Japanese driver's license.

- ♦ Applications to switch foreign driver's license are accepted by appointment only by phone.
 - Phone number 075-631-5181 (Main line: Driver's License Examination Center)
- ♦ Appointment phone hours: Monday through Friday, 3:00 p.m. to 5:00 p.m. for 2 hours (excluding national holidays and year-end and New Year holidays)
- ♦ The date and time of acceptance (submission of application form) will be given at the time of appointment.
- ♦ Application location → Test Reception Window (Window No.6), 1st floor of the main building of the Kyoto Prefectural Police Driver's License Examination Center

- ♦ Documents will be received at the time and date specified at the time of reservation, and will be reviewed through document screening and interviews.
- ♦ As with the document screening, all skill verification is by appointment only. Appointments will be explained after passing the knowledge verification.
- ♦ Applicants who cannot speak Japanese must be accompanied by an interpreter.

Required Documents
□ Foreign driver's license (unexpired) →If the name on the foreign driver's license differs from the name on the passport or other document, an official document providing evidence of the reason will be required.
☐ Japanese translation of foreign driver's license →Translations are only accepted if issued by one of the following: Japan Automobile Federation(JAF), Ziplus Corporation, the administrative agency that issued the license, German Automobile Federation, or Japan-Taiwan Exchange Association.
□ Residence Card(For non-Japanese national only)
□ Copy of certificate of residence (photocopy not acceptable) →The applicant must indicate his/her permanent address if he/she is a Japanese national, and his/her nationality, status of residence, period of stay, and expiration date if he/she is a non-Japanese national. →The document must not contain personal numbers and must be issued within the last 6 months.
Passport →A passport or other document (showing the entry/exit stamp of the country where the license was obtained) is required to confirm that the applicant was in the country where the license was obtained and that the applicant has stayed there for at least three months since obtaining the foreign license at the time of the application. →If the passport does not show an entry/exit stamp, additional proof of entry/exit record or proof of stay issued by the country that issued the license will be required. *See below: "Documents proving the period of stay in the country that issued the foreign license."
□ Photo of applicant's face for application (3cm x 2.4cm) →The photo must have been taken within the last 6 months. →In principle, the photo should be taken without a hat. Please write the applicant's name and the date of the photograph on the reverse side.
□ Black ballpoint pen (erasable ballpoint pens are not acceptable)
☐ Japanese driver's license (including expired driver's license, if you have one)

Occument Certifying the Period of Stay in the Country that Issued the Foreign Driver's License

* The following documents are required to prove that you stayed in the country where you obtained your driver's license for at least three months after its issuance.

① Current valid passport

- \cdot The entry/exit stamps must be clearly stamped. If the stamp is defaced or not stamped, your stay may not be confirmed.
- Please bring your old passport along with your new passport, as you may need it to verify the duration of your stay in Japan. If you have dual nationality, please prepare a passport for each country.

2 Certificate of stay or immigration record

Proof of stay or immigration record issued by a public institution such as a consulate that proves that the applicant has stayed in the country that issued the foreign license for at least three months after obtaining the foreign license.
